# Countryside Pool Rules

The swimming season is here and everyone is looking forward to being able to relax and enjoy our pools during the summer.

If everyone is considerate of other residents we should not have any problems such as one person or group dominating the pool at the expense of other people. However, we do not live in a perfect world and there will be occasional problems that develop. There will be times that we need the residents' help to control the behavior in the pool. Your assistance is appreciated.

## POOL HOURS ARE DAWN TO DUSK

## Pool Rules are listed below:

- 1. No Lifeguards are on duty at the Countryside Pools. All persons using the pool facilities do so at their own risk. The Countryside P.U.D. Residential Homeowners Association, Inc. (Countryside H.O.A.) assumes no responsibility for any accident, injury or loss. Persons entering and within the pool area thereby agree to hold the Countryside H.O.A. and its members, employees and agents harmless for any loss or injury of any nature within the pool area.
- 2. The pool facilities are for the exclusive use of residents and their guests. All others are subject to prosecution as trespassers. Members must be present with their guests.
- 3. Residents are responsible for their own actions and for the actions of their children and guests.
- 4. Only persons wearing appropriate swimwear will be allowed in the pool.
- 5. At all times children 12 and under **must** be accompanied by an adult. Children who cannot swim must **never** be left unattended. After 5 P.M. children 17 years old and under must be accompanied by an adult.
- 6. All persons must take a cleansing shower before entering the pool.
- 7. Persons having a cold, cough, inflamed eyes, infection or wearing a bandage are **not** permitted in the pool.
- 8. Glass containers or breakable objects are **not** permitted in the pool area. No alcoholic beverages are permitted in the pool or adjacent to the pool or on the pool deck. Intoxicated persons are **not** permitted in the pool area. Only Countryside PUD HOA events sanctioned by the Board of Directors will be allowed to serve alcohol in the pool area.
- 9. All refuse must be placed in appropriate containers. No facility or equipment is to be abused or misused.
- 10. No wheeled vehicles, (except those required by the handicapped or attended baby strollers) or toys of any kind and no play equipment **including balls and floats**, (except swimming aids for infants and small children or those who cannot swim) are permitted in the pool area. Soft water toys will be allowed in the baby pool only. Ball or Frisbee playing is not permitted in the pool or pool area. Styrofoam noodles used as swim aids and swim goggles are allowed.
- 11. No pets are permitted in pool area, except service/guide animals that are clearly labeled as such.
- 12. <u>No</u> running, pushing, dunking, rough play, standing or sitting on another person's shoulder, <u>diving</u> from ladders, profane language, spouting of water or any unhygienic actions are permitted.

- 13. All babies must wear <u>swim diaper</u> protection in the pool.
- 14. The **POOL RULES** will be strictly enforced. Members and guests who do not comply with the rules will be asked to leave the pool area. Those members who do not comply may have their pool privileges denied by the Board of Directors.
- 15. Any member may enforce the provisions of these rules but reporting violations to the office is preferable to avoid confrontations between the members.

#### **Pool Access Procedures**

- 1. The pools are for members of the Association in GOOD STANDING (Assessments current for both Mini and Master Association and no covenant violations) and their guest only. Access is strictly controlled by the association and nonmembers or members who do not adhere to these procedures will be denied access to the pools and/or asked to leave the pool area.
- 2. Members must have a Pool Key card to enter the pool area. During their stay at the pool, the member may be requested to verify their membership in the association by presenting the pool key card to the office or any employee of the association.
- 3. Members may bring up to four guests to the pool. The members **must** be present with their guests.

### **Obtaining Pool Key Cards**

- You can obtain a pool key card at the office for \$6.00 each for the first two and \$50.00 each thereafter. Members
  must present a valid ID or utility bill stating that they reside at a residence within the Countryside H.O.A. to obtain a
  pool key card. Limit of 2 cards per household.
- 2. Renters must provide a copy of their lease to get their pool key card. If the owner has already obtained a key card, another key card will not be issued to the renter.
- 3. Lost cards must be reported to the office.
